Whilst the numbers have dropped dramatically and we have been assured that we will not be tied into Coventry & Solihull figures this time - the more recent figures from the last 3 days have shown an upturn... There has also been an outbreak at Warwick Hospital which affects capacity, inpatients and staff plus threatens any change in our tiering...

 - Plus optional (Chargeable) 2 weekly garden waste service
- Agreement that the Electoral review working Group document will be submitted to the Local Government Boundary Commission in 2021

Council Budgets

Tier 3 has obviously made the situation worse as our income streams are reducing (less car parking revenue) and companies making staff redundanct = less Council tax. We have been looking at ways to address this – we are going to be making very unpopular changes – nothing is being ruled out because we simply don't have the option to do so. Inevitably services will be reduced, Council tax is going to go up and we will be looking to charge for services which were previously free including things like ALL District car parks.
