21/00146/FUL - The Conifers

Resolved: Committee discussed the plans and resolved they **OBJECTED** to the application, for reasons following:-

- 1. It runs counter to the tenets set out in Policy CS5 of the SDC Core Strategy in that it fails to satisfy Part A by not having regard to the local vernacular of this small hamlet. Similarly to Part B there is no assessment of the likely visual impact on the local landscape.
- 2. The design fails to recognise the character and local distinctiveness of the Arden Character Area as set out in Development Requirements Supplementary Planning Document (SPD)
- 3. It runs counter to Policy CS9 Design and Distinctiveness parts A,B and C

4. Development Requirements (SPD) Part E sets out detail of building types and material constituents for construction compatible with the Arden area of the SDC and the proposals as written fail to recognise the design criteria appropriate to this form.
