Last time we spoke Henley-in-Arden & Claverdon had 17 cases – it is now at 25.

Since the start of September we have unfortunately had a 1 death in the District where coronavirus is mentioned on the Death certificate.

Finances

Based on results for the period April to July, the current forecast is that there will be shortfall in net income by the end of the financial year of about £1m. Rather than hoping to make some contribution towards rebuilding SDC's reserves this year, there will be a need to finance the shortfall against budget by again drawing on reserves. The pressure remains on SDC's finances simultaneously to generate additional revenue and to make savings, both through its own operational decisions and through the advantages that the merger with WDC hold in prospect.

Markets

We have recently had two very successful events :

(i) The National Young Traders Market Final – Stratford has been home to the final for the last few years (cancelled in 2020). This is a showcase for the talent and ingenuity of young market traders from all around the country. The event was a tremendous success with the NMTF agreeing to bring it back to Stratford next year. (ii) Food market & Dragon Races – both on the same day. It brought in thousands of domestic tourists and once again, it was a real success.

Welcome Back Project Update

This is progressing at pace. Projects are beginning to take shape with the eight main rural centres including purchase of Gazebo's for new local markets, animated displays for Christmas markets and village centre improvements such as planters.

Planning

In the wake of Full Council signing up to a Climate Change Emergency, there has been a flurry of both pre-applications and planning applications for solar farms by developers who have been targeting landowners. Consequently, difficult decisions lie ahead for those of us in rural wards as we look to balance arguments from residents with the benefits of renewable energy sources and the terms of SDC's policies. A review of these planning applications from a cumulative site perspective is currently been undertaken. Guidance for ward members will be produced and circulated soon – I will pass a copy to the parish when I get it.

Land Charges

The service has been transformed since the transfer of the register to HMLR. The team is fulfilling an eleven days' performance turn around against a target of fifteen days, despite search requests remaining high throughout August and September.

Do Not Drop Litter Roadshow

It was due in Henley on the 23rd September but due to lack of space (as there were road works ongoing outside the old Barclays Bank site) this was postponed – when I get the details of the rescheduled date I will let you know.

Stratford Herald Covid Awards

The *Stratford Herald* has launched the Covid Response awards that will recognise the achievements of the District's businesses and organisations over the past 18 months. The Awards will be a celebration of the positives to flow from the hardship, isolation, loss and worry caused by the coronavirus.
