
Educational Attainment between district councils/boroughs

I was lucky because my junior school really encouraged me, and I eventually went to grammar school. I don't know what the factors or drivers are that account for the anomalies in educational achievement and attainment, but I want to find out as the great phrase "levelling up" should include and start with children's education. Your District councillor will cover of most questions regarding this plus I have put a brief reminder of the app. in my weekly report but whilst SDC are the collection authority County is the disposal authority and I would urge residents to put their waste food into the caddy for collection each week. This is then taken via a smaller and separate truck to one of two centres where it is bulked and then taken to the Severn Trent's facility at Coleshill. Millions of tonnes of waste food from households, supermarkets and restaurants are thrown away in the UK every year, a large proportion of which ends up going to landfill or travelling miles to treatment facilities. Rather than letting this food waste go to waste, Severn Trent is capturing it locally and using it to generate green renewable energy to help reduce carbon emissions and landfill waste.

Delegated Budget

The Delegated Budget scheme has been very popular with members since it was introduced in 2015. It is an annual £2M budget shared amongst Members which they can use to deliver minor highway works which benefit communities. It provides a good way of involving members in the prioritisation of local works and has offered opportunities to undertake works that would not have otherwise been possible given highways prioritisation towards safety and maintenance need or budget constraints. It can often be used to address local issues raised by parishes, wards, community groups and residents which would otherwise not be prioritised. I am in the process of creating a spreadsheet of what has been spent and what is remaining of the budget plus a list of all the projects that have benefitted from this, so far this year. I have to split this over the whole division so I am always looking for match funding as well so that as many schemes as possible can be considered.

At present I can't see anything in the lists for Henley, but I am told by Scott Thompkins that the website is being updated and will be complete with costs soon plus timescales. Let me know if you feel that a project was submitted so I can follow this up.
