Our Vision

Our vision for South Warwickshire is that by 2028, Stratford-on-Avon and Warwick District Councils will have contributed to creating a larger, stronger, greener and more inclusive economy.

Our Mission

Both Stratford-on-Avon and Warwick District Councils have declared climate change emergencies and are committed as organisations to achieving net carbon neutrality by 2025. Aside from the positive environmental impacts of achieving carbon neutrality, mitigating and adapting to climate change will generate positive economic impacts and new opportunities for jobs and investment in new sectors, driving forward innovation in existing sectors and creating the cross-fertilisation of ideas. The Councils want to capture and capitalise on these opportunities and see South Warwickshire leading the way in decarbonising the local economy while promoting growth and social inclusion. Our mission, therefore is:

To foster the growth of the South Warwickshire economy sustainably and equitably. Working together, we will seek to achieve economic participation and prosperity for everyone in South Warwickshire. We will also lead the way and take smarter steps towards a greener future to meet our ambitions for a 55% reduction in South Warwickshire's carbon emissions by 2030.

The JPC supports the bulk of the Vision and Mission statements. We have a significant reservation about the 2023-2028 timescale. There are three reasons for this.

- Most economic activity has a longer development period than 5 years especially when targeting strategic sectors.
- The SWES is intended to integrate with and support the Local Plan. As the local plan period is 2025-50 a 5-year period is incompatible.

The JPC suggests that the SWLP has intermediate development periods of 5 years and the SWES covers at least 15 years in three 5 year plan periods.

Objective 1 skills: we support these priority actions

Objective 2 Housing: We do not support these priority actions for the following reasons.

- None of these are mentioned in the Local Plan,
- None are directly related to SDC policies
- Point 1 appears to be a direct contradiction of SDC strategies.
- None of them seem to have direct relevance to the Henley area.
- 100% affordable housing development would only be possible with enormous public subsidy which will not be available.

Objective 3 Stronger sectors - the JPC supports the priority actions 3.1-3.7 except for 3.3

Priority action 3.3 targets the increase in visitor centres across the sub-region. The actions need to target the key assets of the area such as Stratford/Shakespeare /Arden and Warwick Castle. Tourism is treated largely as a problem and a much higher priority to a vibrant sustainable and targeted sector is appropriate.

Objective 6 Infrastructure: Priority actions 6.1-6.7

The JPC is very concerned about the approach to infrastructure. The SWLP identifies the Henley area as a possible centre for significant housing growth. When we consulted the community about these plans they had two main concerns , that any new development was compatible with the existing character of the town and they would only support new development which was backed by significant infrastructure improvements.

It is a stark reality that none of the priority actions have a direct impact on Henley. The Core Opportunity Area covers large swathes of the sub-region.

Henley/Beaundesert quite clearly lies outside the COA.By definition the priority for infrastructure resources and policies will be within the COA.The detail in Priority Actions 6.1-6.7 demonstrates that this is already the case. The JPC is therefore mandated to object to this formulation.

Objective 7 Vital High Streets. The JPC supports these actions but assumes that the consultation will be with parish Councils as well as Town Councils.
