<u>WHEREAS</u> the Warwickshire County Council ("the Council") as traffic authority for D5120 Meadow Road, D5239 Riverside Gardens, D5121 St. Nicholas Road & D5123 Mount Road, Henley in Arden is satisfied that traffic on the said roads should be restricted by virtue of works proposed to be executed thereon or near to

<u>NOW THEREFORE</u> the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:

- This order shall come into operation on 29 August 2023 and may be cited as "The Warwickshire County Council (D5120 Meadow Road, D5239 Riverside Gardens, D5121 St. Nicholas Road & D5123 Mount Road, Henley in Arden) (Temporary Prohibition of Traffic) Order 2023".
- 2. No person shall cause or permit any vehicle other than an exempted vehicle to use the roads in Henley in Arden as indicated in the Schedule below for a period of 18 months commencing on 29 August 2023, or until the said works are completed, whichever is the earlier.
- 3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
- 4. The provisions of Article 2 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.
