# County Councillors report as of 22nd April 2024 (updated 1st April report)

I am available most days of the week and my day regularly starts at 8am and runs to 10pm some days. Contacting me by email is always best as I am often in meetings with residents, business owners, farmers, and officers. I spend many hours reading papers for and attending committees, with reports regularly being in excess of 200 pages. Local government seems to thrive on voluminous report.

My last 12 months in Henley in Arden have been dominated, locally, with 4 issues

- Flooding
- Speeding
- 20mph Scheme
- Potholes

Over the last year I have received 227 requests for help across my County Council division with approximately 33 being from Henley (14.5%).



### The Director of Public Health annual Report 2023 — Breaking the Silence:

**Working together to Prevent Domestic Abuse** has just been published and focusses on the health impacts of domestic abuse and whilst this is a very serious issue, I can recommend this report to everyone as it has been written in a unique style which is informative, interesting, and incredibly easy to read and understand.

Throughout Warwickshire approximately 17,384 women, aged 16+, were estimated to have been impacted by domestic abuse between 2021-22. Nationally, 9% of women, aged 16 and over, were victims of domestic abuse in 2022. Furthermore, data suggests that 8% of women aged 18-74 experience abuse before the age of 16. This can have devastating impacts to the victim survivors physical, mental, emotional, sexual, and reproductive health.

This year's Annual Report builds on previous publications such as the Violence Against Women and Girls (VAWG) strategy (2023-2026). It takes a new approach, telling the story of a character named Mia, and her experience of domestic abuse, through the words of those surrounding her, and services involved. Whilst this story is fictional, the story is reflective of real-life experiences of domestic abuse, and it is intended to highlight the impact on victim-survivors, the communities in which we live, our services and wider society. ## **Henley in Arden Specific**

### Parking in Front of the Co Op

The sub-committee raised the following issue with me.

Currently with the traffic warden only visiting Henley on a Weekly Basis and the allowances they currently are giving to cars parked at this bottle – neck, the double yellow lines are not a deterrent. Added to this that maybe 35% are parked legally as disabled car users can park there, but this does nothing to ensure the safety of the pedestrians at these points.

The proposal that has been suggested by the subcommittee is as follows:

- red lines going down in the centre of the town, on both sides of the road. In our view a single red line should go from the CO-OP to the Henley Boutique and a double red line on the opposite side of the road. Vehicles are allowed to stop on single red lines at certain times of the day which in our view should only be delivery lorries and council refuse trucks. A sign would have to state what times this can take place. Further discussion needs to take place on these times.
- To ease congestion in the High Street it is suggested that **all** pavement / pedestrian bollards from the CO-OP all the way to MPA Financial Management Ltd should be removed. The pavement could then be reduced

in width to make deliveries easier, but still acceptable in width for wheelchair pedestrians. This would need to be policed and thus probably one or two cameras would be needed to read the number plates of the illegally parked vehicles, one in front of the CO-OP pointing in the direction of the Henley Boutique and one from the Henley Boutique looking back towards the CO-OP.

Additional disabled bays in the Croft car park and along the High Street

I have spoken with the small works team leader, and he has confirmed the following: -

- Red Routes are reserved for instances of heavily trafficked urban roads where there is a need to control parking to maintain the free flow of vehicles over and above the normal prohibition of waiting and loading, which does not prevent vehicles stopping for the purpose of picking up and setting down passengers, which in itself can contribute to traffic congestion on very busy roads. They are intended to be used strategically to deal with traffic problems assessed on the whole-route basis, not to deal with issues on relatively short lengths of road. Warwickshire does not have any routes which are deemed to meet this requirement.
- WCC own the first 1.9 metres of footpath on Henley High Street outside the shops, the shop owners own the remainder, so we can't put a Loading Bay in, as there wouldn't be any Public Highway left for them to walk on. This would not be approved

Whilst the loading bay is probably a nonstarter because the shops might not agree to the change, it would be a costly and lengthy legal process as well involving traffic regulation orders and a consultation. This is not to say it couldn't happen just that you need to first get the agreement of the various shops and match funding from them.

It is essential that the views of the businesses along the stretch of the High Street where the loading bay might be placed are considered. Adding more disabled bays into the Croft car park would be a matter for the Parish Council and I would need more details on how many more bays you are thinking of on the High Street, as this will further reduce parking for other residents. Again, this is not to say it couldn't be carried out.

There is always a balance to be had regarding pedestrians and traffic, especially along a High Street such as in Henley and I think that we would need to demonstrate that pedestrians of all or any abilities and ages are at risk with the current situation. The shops, businesses and residents might take a counter view to the changes. Policing of the on-street parking is by the County and on a regular basis already. The problem is that as soon as the enforcement officer leaves the area drivers park again, realistically this is unlikely to change and with constraints on budgets, increasing the team of enforcement officers is not likely to happen either as there are bigger issues in other parts of Warwickshire. Fines work initially, as Hockley Heath found out when installing average speed cameras but now there is little to no income from these cameras so the residents must pay for them via the council tax. Would the residents of Henley who are not near to the High Street be prepared to pay more on their council tax to support these changes and will the County be prepared to increase the officer numbers as this would set a precedent that other Parish and Town councils would want to take advantage of. Any additional cost must be balanced with additional revenue as council tax payers are already seeing average rises of 4.7% in council tax with the possibility of bigger increases in future years due to the costs of children and adult social care, SEND and home to school transport all of which accounts for 70% of the council tax that the County receive currently. Adult social care is increasing because we are living longer and have an aging population.

**Flood Team Sub Committee** – I am awaiting a response from the County Council Flood Team who are setting up a meeting with the Environment Agency. Severn Trent, Canal & River Trust, and the subcommittee to discuss the flooding issues.

**20 mph scheme –** The big planter at the North End of the town is the subject of concern by the Highways Team and a request has been made to the Clerk to have this moved.

**Gully Cleaning** - have been asked if I would like to pay for the hire of a gulley cleaner from my budget, so that all the gullies in a particular location, where we have a report of a blockage, will be cleared on the same day. This is a trial and will cost £1,000 per day I have the gulley cleaner/jetter. I have 10 parishes, so this is potentially a big charge against my budget, but this is worth doing. Please ensure that any blocked gullies are logged as soon as you see them as the Localities Officer will shortly be putting lists together for each location so that we can plan the routes.

**Bird Flu – Protecting poultry industry from bird flu –** As we have a Game bird, turkey, geese farm near to Henley on the A4189 I thought I would highlight the new measures to better protect the poultry sector from future avian influenza outbreaks have been set out by the Government. Under the changes announced there will be new requirements for all bird keepers regardless of the size of their flock to officially register their birds. Currently only those who keep fifty or more poultry must do so, limiting the effectiveness of our national disease control measures. The new rules cover owners of backyard flocks, birds of prey and pigeon fanciers. They do not affect caged pet birds (excluding any poultry species) kept entirely inside a domestic dwelling, such as a parrot, canary, or budgie, which never leaves the property other than to visit a vet or another short-term period.

## Strategic Economic Plan approved at Cabinet



The three pillars of the Strategic Economic Plan each have dedicated areas of focus which includes the actions that will be taken to create impact and the outcomes.

The Ambitious Growth pillar encompasses supporting businesses with high growth potential to start or scale i.e., grow organically at a manageable rate and a future economic strategy will seek to increase the numbers of businesses accessing finance. It highlights how the county council will continue to foster research and development.

This is a Warwickshire-wide strategy that sets out the purpose for Warwickshire to have an economy that is ambitious, inclusive, and sustainable which will be achieved by working with a wide range of partners and focus on building a strong viable and resilient economy.

Work is already underway to establish a delivery plan that will underpin and help achieve the key objectives in the SEP.

Warwickshire's Strategic Economic Plan highlights the work that the county and its partners are doing with three pillars that are key to developing an economy that is

- fit for the future
- that will grow and create jobs for all of the county's communities
- and will be sustainable and contribute to the county's net zero carbon emission targets.

The infrastructure of the transport system and digital connectivity and ensuring that land supply meets the needs of growth are key aspects.

Talent – attracting and retaining it with high-quality employment – is integral to Warwickshire's growth. There are plans to work with the Department for Business and Trade to investigate potential for exporting.

The Inclusive Growth pillar will target support for employment and will look to work on the outstanding success of the Warwickshire Supported Employment Service, which has made such strides since its launch in engaging some of the county's residents who have previously struggled to find employment with businesses. It will also bring together local partners such as the Growth Hub and the Chamber of Commerce and national partners including the Department for Work and Pensions.

Raising aspirations in low output areas of the county and developing clear career pathways will be among the targeted support for employment, as the strategy seeks to level up opportunities across Warwickshire. Regeneration of priority areas and empowering communities will be key to achieving this. The strategy will seek to encourage enterprise in such areas as well as in under-represented groups such as women or minority ethnic backgrounds.

The developing jobs market is another core focus of the county's planning with schools and colleges being supported to develop career activity that is relevant for the needs of the future.

Finally, Sustainable Growth, which will underpin businesses' transition to net zero, makes up the third pillar. Supporting low Carbon tech businesses and encouraging new ones while ensuring there are the skills in the job market to make the transition is key to the plans for the strategy. Key partners will be assisted in decarbonising transport across the county. Businesses will be supported to reuse, recycle, and reduce materials. Residents will be encouraged through various means across a range of council services to increase the use of active travel; businesses will be supported in a move to using sustainable freight.

**Potholes -** Warwickshire is to receive, for the next 11 years, £2.056M additional funding for highway maintenance each year as part of the money being repurposed from HS2. This funding is specifically for maintenance works on highway assets including roads, footways, street lighting, bridges, traffic signals and highway drainage. Whilst none of that funding will be used to directly repair potholes, a substantial proportion is likely to be spent on road surfacing schemes which will prevent pothole from forming

over the long term. We have yet to determine exactly how the funding will be spent but the team is looking at some of the high-cost maintenance schemes that are typically not affordable from the annual government grants for maintenance and working on prioritising schemes. We repair our potholes using a combination of revenue funding, as well as capital funding. Generally, the revenue funding is used for reactive repair, and the capital funding is used for pro-active repairs to larger areas where potholes will likely form. For 2023/24 our budget for revenue defect repair gangs is £1.970m, these gangs repair potholes but also all manner of other highway defects. In addition, we will spend approximately £1.75m of capital on small patching works.

**So far, this financial year we have repaired 7,890 potholes across the network**. Warwickshire has a strong reputation for making repairs and we are ranked 4<sup>th</sup> out of 30 peer authorities in the National Highways and Transportation Survey for overall highways maintenance, condition of highway and how guickly we deal with potholes and damaged roads.

**Test your smoke alarms** - Warwickshire Fire and Rescue are reminding everyone to make sure that they have working smoke alarms fitted in their homes and to test them regularly. Residents are being urged to make sure they have working smoke alarms fitted in their homes and to test them regularly. As part of the latest Fire Kills campaign, Warwickshire Fire and Rescue Service (WFRS) is reminding people of the importance of smoke alarms in saving lives in the event of fire. Smoke alarms can give someone the few extra seconds they need to escape in a fire. Testing takes only a couple of seconds, but it can save lives. While most homes across the country now have alarms fitted, most people are not aware that the average alarm has a lifespan of just ten years before it needs replacing. With that in mind, WFRS is asking residents to ensure that their smoke alarms are up to date and up to the job.

Here are their top safety tips:

- 1. Make sure there is at least one smoke alarm on every level of the home
- 2. Test smoke alarms at least once a month
- 3. Check that smoke alarms are less than 10 years old
- 4. If you have a smoke detector which runs on a battery that needs replacing, make sure to change it once a year
- 5. Fit smoke alarms in the right place on landings and hallways and near bedrooms. Consider fitting them in rooms which have electrical appliances e.g., a heater or charger or other fire risks
- 6. Check on neighbours or loved ones who may need help to ensure they're fully protected
