#### 5..BROWNFIELD/ GREY LAND AND GREEN BELT

- BROWNFIELD DEVELOPMENT DEFAULT 'YES 'BUT NOT ENOUGH
- PLANNING AUTHORITY TO UNDERTAKE GREEN BELT REVIEW TO RELEASE POOR QUALITY GREY LAND SUBJECT TO SUSTAINABLE PRINCIPLES AND GOLDEN RULES
- LOOK FOR OPPORTUNITIES TO MAKE SUSTAINABLE EG TRAINS.
- NO GENERAL RELEASE FROM GREEN BELT BUT PLAN /VISION LED APPROACH

#### **GOLDEN RULES FOR PUBLIC BENEFIT**

- AT LEAST 50% AFFORDABLE
- IMPROVEMENTS TO LOCAL OR NATIONAL INFRASTRUCTURE,
- NEW, OR IMPROVED LOCAL GREEN SPACES
- COMMITTED TO DELIVERING MORE GENUINELY AFFORDABLE HOUSING TENURES, SUCH AS SOCIAL RENT.
- HOUSING MIX UNDER THE GOLDEN RULES SHOULD BE FOR LOCAL DECISION
- LIMITED GREEN BELT RELEASE, PRIORITISING GREY BELT, PROVIDES OPPORTUNITY FOR LANDOWNERS TO SELL LAND AT A FAIR PRICE
- AUTHORITIES TO TAKE A PROACTIVE ROLE IN LAND ASSEMBLY
- BEST WAY TO ACHIEVE ECONOMICALLY TO IMPROVE DEVELOPER CONTRIBUTIONS
